Presentation: 5 g of powder, packaged in sachet bags (30 sachets).

Composition: powdered sugar (carrier), L-arginine, citric acid (acidity regulator), magnesium citrate, amorphous silicon dioxide (anti-caking agent), ascorbic acid, natural cranberry flavor, sacre vitex tree extract, zinc citrate, alpha-tocopherol acetate, stevioside (sweetener), dye, pyridoxine hydrochloride, riboflavin, folic acid, potassium iodate, sodium selenite.

Scope of application: recommended as a dietary supplement for women – a source of L-arginine, an additional source of vitamins C, E, B₂, B₆, B₉ (folic acid), macro- and microelements (magnesium, selenium, zinc, iodine), containing iridoids.

Recommendations for use: women: once daily with meals, dissolve the contents of 1 sachet bag in 1 glass (200–250 ml) of water. The course duration is 1 month.

If necessary, the course can be repeated.

Please, consult a doctor prior to use. People with thyroid diseases are advised to consult an endocrinologist prior to use.

Contraindications: individual intolerance to the components, pregnancy, breast-feeding, carbohydrate metabolism disorders.

Storage conditions: in a dry place, protected from direct sunlight and away from children, at a temperature of no more than 25 °C.

Sales: through pharmacies, specialty stores of dietary products, special departments of food stores.
